Interim meeting in Athens 29-30 October 2010

EUROPE AND MEDIA - NEW DEVELOPMNETS IN SOCIAL THEORY AND RESEARCH

Media studies in Europe have mushroomed in the last decades. The globalization of communications and the enlargement of the European Union have forced media researchers to constantly broaden their horizons and reassess their approaches. Our next Network meeting is especially concerned with these changes.

Abstracts are invited for papers to be given at the next meeting of the Network on October 29/30 2010 in Athens. Papers are particularly invited where they address the theme of the meeting, and as a network of the European Sociological Association we remind colleagues that formulation of research in relation to sociological theory and concepts is especially welcome, as is empirical work which addresses comparative topics and the major concerns of European sociology. This will include work which deals with questions about identity (national, ethnic, European) and how that relates to media consumption, the development of new media in Europe, the political economy and social networking, European newspapers in the age of the internet, Google vs. European publishers, European public sphere after the financial turmoil and the communication crisis, etc. We do not take 'Europe' as itself an unproblematic concept. New thinking on all these topics will be very welcome. It is likely that a publication will arise of the best papers at the meeting.

The meeting will also afford time for general work reflecting the diversity of research activity among our members. The first criteria for selection will be excellence of research and general interest to network members. We are particularly interested in papers that take a comparative view on communication practices in Europe. We also encourage critical and interdisciplinary approaches aiming to create a dialogue between a broad diversity of methodological and theoretical approaches.

Presentations will be no more than 20 minutes, though fuller papers will be required for circulation. Work in progress is welcome, and authors should not feel inhibited from presenting work which is still being developed or is incomplete.

Home, Migration and the City: New Narratives, New Methodologies

Programme

There has been a recent surge of scholarship from human geography, sociology, history, architecture, and cultural studies that focuses on migration as a social, political, cultural and material process. This area of research on migration examines migrants' transnational spatial practices, social and political identities and relationships with the state. Central to this research has been a recognition that at the heart of migration lies a fundamental transformation in spaces and places that are linked to the social and cultural meanings of home and belonging.

Migration brings about a material change in the places and locations through which notions of identity, individual expressions and belonging are transformed. Through the movement of people, for instance, cities, homes and localities become re-narrated through migrants' stories, photographs, music, artwork and films. Cities in particular, as places of origin and (re)settlement become key sites of migrants' experiences of 'home'(s). The experience of Europe over the past fifty years is a good example; urban spaces have increasingly become contested locations where the spatial and material nature of identities are negotiated - Muslim/Christian, European/non-European, first/second generation of migrants. Much migration research, moreover, connects home and nation by investigating migrants' connections with past, present or imagined 'homelands'. Home can now also be described as translocal, transnational and diasporic - shaped by consumption, remittances and social networks. The domestic spaces inhabited by migrants are especially important for their roles in constructing attitudes and behaviours towards 'others' when strangers share living spaces in the city. Home can even be redefined through its 'socio-technical' differences across national spaces. This conference offers an opportunity to bring these social, spatial, material and technological facets of migration together - to consider migrants' identities and experiences of homes and cities, and the material, aural and visual landscapes of mobility and movement.

This conference takes 'narratives' – broadly defined as stories, diaries, myths, photographs, music, films, media images and representations of movement – as the analytical starting point for new research on migration. Narratives have several dimensions. Firstly, migrant narratives need to be understood as inherently spatial. As is widely acknowledged, migrants' stories of movement are often stories of different places at different moments, and thus are essentially 'spatial stories'. Secondly, this spatiality of migration narratives is multi-scalar; it can relate to belonging on a national, political scale, represent locality dynamics, more small-scale, personal experiences of migration, or even the material narratives of migration, such as stories of significant objects and material culture. The political element of the larger scale narratives is especially important; it is these that foster the exclusion and inclusion of migrants in societies. Thirdly, the performative element of migrants' narratives is very strong; not all narratives are textual but instead are enacted through music, theatre, film, food, or dance. Finally, such narratives can also be highly visual, corporeal, and embodied, whether through media representations, artwork, or architecture. Such a broad conceptualisation of migrant narratives demands new interdisciplinary theories and methodologies to understand the interconnected landscapes of home, migration and the city.

Due to globalization and new technologies we have a growing awareness of living in a world remarkably comfortable and absolutely poor at the same time. We watch live and direct disasters and suffering (war, famine, hurricane, etc.) all around the world. Media and international humanitarian organizations have become proactive actors in the global arena of the representation of suffering.

The panel focuses on the visual construction of human suffering, with special reference to the signifying practices of the media and humanitarian campaign events. The panel aims to focus on the "spectacle of suffering" proposing a reflection and discussion on the role, impact, effectiveness, limits and risks of the insistence on spectacular images of suffering, and the combination of humanitarian discourse of compassion for the victims.

In your paper, be sure to answer to some of the following questions:

- What do we actually get to know about global crisis and life of people involved in humanitarian emergencies?
- How does the representation of victims impact the frame of reference for our moral and social values?
- What kinds of responsibility have media and NGOs strategies of communication in building a respectable global citizenship?
- Could we focus humanitarian assistance as a substitute for political initiatives and solutions?

PROFESSIONS AND INSTITUTIONAL CHANGE

Journal of Management Studies Special Issue

There is a growing awareness of the critical role that professions play in advanced economies. Professionals and professional service firms are key advisors, analysts, defenders and developers of the major institutions that underpin capitalist economies. As gatekeepers to key financial institutions, the professions influence both the success and failure of capital markets. Professional service firms are also powerful economic actors in their own right, contributing over 3 trillion (USD) to the global economy.

Professions influence more than the market system, however. They are also key agents of social change. As Scott (2008: 219) observes, "the professions in modern society have assumed leading roles in the creation and tending of institutions. They are the preeminent institutional agents of our time." Professions are, themselves, institutions which, over the last thirty years, have experienced profound changes. Professional service firms are increasingly adopting both the logic and structures of business corporations (Brock, et al., 1999). Professional identities are increasingly framed around logics of efficiency and commerce which have displaced traditional logics of ethics (Brint, 1994). Professional firms now tend to be multidisciplinary and transnational; a development which is eroding the value of traditional self-regulatory regimes and making the professional service firm the primary site of professional control and regulation (Cooper & Robson, 2006).

While we understand that professions are both key mechanisms for, and primary targets of institutional change, the precise role of professions and professional service firms in processes of institutional change remain under-theorized (Hwang & Powell, 2009; Scott, 2008). In this Call for Papers we propose a substantial re-theorization and empirical re-examination of professions and professional service firms and their relationship to the dynamics of institutional change.

Theoretically we seek papers that focus on the institutional work (Lawrence, et al., 2009) of professions in the context of business and the capital market system. Specifically, we are interested in research that theorizes the role of professionals and professional service firms in creating, maintaining and changing key societal institutions. We thus encourage submissions that focus on, but are not limited to:

- The role of professionals and professional service firms in creating, maintaining or changing key institutions within capital markets
- The role of professionals and professional service firms in creating, maintaining or changing key institutions within government and society
- The changing social, normative and ethical role of professionals and professional service firms
- The role of professionals and professional service firms in the diffusion of institutional logics
- Changes in status, identity, function and role of professionals embedded in corporations as inhouse professionals (i.e. in-house lawyers, consultants, internal accountants etc.)
- The emergence of new forms of business professions and professional service firms

Empirically, we seek papers that document and analyse how broader institutional changes have impacted on professional services firms and their activities. We thus encourage submissions that focus on, but are not limited to:

- Changes in the structure and organizational design of professional service firms (including multidisciplinary firms, publicly traded professional firms and transnational professional firms)
- The emergence and role of new managerial practices within professional occupations and professional service firms
- Emerging networks of professionals and professional firms (including alumni networks and global professional firm networks)
- Changes in the nature of professional work (such as the off-shoring professional services and the impact of new technologies)
- Changes in professional identities as a result of the increasingly organizational context of professional work
- Changes in the status and perception of professionals as a consequence of the increasing deregulation and fragmentation of the professions
- Changes in the power relationship between professions and clients

While much recent research has focused on traditional business professions (consultants, lawyers and accountants) we also encourage studies of professionals and professions that have received somewhat less analytic attention – such as engineering, health care, information technology and lobbying. We also encourage studies that examine multiple professions or the field as a whole.

We also encourage papers that challenge the assumptions of this Call for Papers – i.e. papers that question the extent of change in professional service firms, their role as agents of institutional change or the relevance of professionals and professional service firms as a managerial construct.

Papers may take varying methods and approaches: conceptual, theory building, meta-analytical and empirical. Recognizing the multidisciplinary nature of this area, submissions may draw on history, geography, political theory, sociology, economics and organization theory.

Submissions should be prepared in accordance with the *JMS* Style Guide for Authors: see http://www.wiley.com/bw/submit.asp?ref=0022-2380. Manuscripts should be electronically submitted by e-mail to professions.special.issue@googlemail.com. The deadline for submissions is December 31, 2010. Papers will be reviewed by the guest editors as soon as they are received and, if suitable for the special issue, immediately entered into double-blind review processes in accordance with JMS standard procedures.

The language of citizenship has, in recent years, been mobilized by feminists to articulate a wide range of claims and demands. The notions of economic, political, social, cultural, sexual/ bodily, and intimate citizenship, for example, have all been developed and explored in terms of their normative potential and their actual realization. In Europe, in particular, there has been a strong steer from research funders and policy makers towards research agendas which address the question of citizenship in the context of increasingly diverse and multicultural societies. But, can the concept of citizenship encompass the transformations that feminist politics seek? What are the restrictions and exclusions of contemporary forms and practices of citizenship? How does the concept of citizenship deal with power, inequality, and difference? What are the problems with framing our desires and visions for the future in terms of citizenship in a globalizing world of migration, mobility, armed conflict, economic crisis and climate change? Does the concept of citizenship restrict our imaginations and limit our horizons within nation-state formations? Can it ever really grasp the complexity of our real and longed-for attachments to communities, networks, friends and loved ones? Is it able to embrace the politics of embodiment and of our relationships with the non-human world? How have feminists historically and cross-culturally imagined and prefigured a world beyond citizenship? Is a feminist, queer or global citizenship thinkable, or should we find a new language for new forms of belonging?

The conference will take place in central London.

A small number of bursaries will be available to people presenting papers at the conference. Bursaries will cover registration fees only. The deadline for sending the Bursary Application form was 4th January 2010.

International Workshop

The Professionalization of Higher Education Management? Comparative Perspectives on University Leadership and Administration

German Research Institute for Public Administration Speyer/Germany September 6-7, 2010

Topic:

Similar to broader developments within the non-profit and public sector over the last two decades publicly funded higher education organizations in most OECD countries have been subject to profound organizational transformations. Despite very different culturally embedded models and national path-dependencies there is a general trend towards a more "managerial regime" of university governance and institutional self-management. While there has been broad interest in subsequent institutional responses of universities and implications regarding research activities, changes of university leadership and administration have received less attention in theoretical and empirical research so far. To this end the workshop addresses the following questions:

- How is university management organized, and what differences occur across countries, institutions and functional areas?
- What are the patterns of recruitment, professional roles, training and knowledge exchange of those being part of university leadership and the administrative staff?
- What occupational and organizational changes within higher education management can be observed and to what extent can this be understood as professionalization?
- What does university leadership mean in an organization that is based on loosely coupled structures and strong heterogeneity?
- Can we really observe a shift from administration to management or is this mainly a re-labeling process?
- How do organizational and occupational changes within higher education management correspond to processes of professionalization in other areas of public sector and non-profit organizations?
- What are the implications and effects of organizational and occupational change within higher education management, what are the related costs and benefits, and how is the interplay with faculty and bodies of academic self-governance?

Keynote:

The keynote lecture will be held by Prof. Walter Powell (Stanford University).

Aim and output of the workshop:

The workshop aims at bringing together scholars and contributions to higher education management from a variety of disciplinary and transdisciplinary perspectives and from very different countries. It is especially targeting theoretically and empirically oriented scholars from organization studies, comparative higher education research and studies in public administration. A publication based on the papers of the workshop is scheduled for 2011.

International Summer School on Evaluation Research

RESEARCH AND PUBLIC POLICY EVALUTATION THEORETICAL AND METHODOLOGICAL LINKS

Lille, France August 30 – September 3, 2010

Objectives of the summer school

The *International Summer School on Evaluation Research* is a forum for comparing and contributing to scientific research on public policy evaluation. This call for papers therefore aims at any type of research relating to public policy evaluation, provided that it studies evaluative practice, regardless of the angle or approach. Papers are expected to take a self-reflexive position, in particular, by distancing themselves from the simple narration or account of an evaluation experience.

All academic disciplines are invited to contribute their reflections and results. For instance, both disciplinary and interdisciplinary work in epistemology, economics, sociology, political science, geography, law, epidemiology, the management sciences, the educational sciences, philosophy and psychology is welcome. Our aim is to collect the broadest range possible of research "for", "about" and "on" evaluation, regardless of the discipline it stems from, from an international perspective.

Topics discussed

Three key areas of investigation have been identified: (i) Evaluation research and development (ii) Interactions between academic disciplines and evaluation, and (iii) The epistemological and paradigmatic roots of the links between public policy research and evaluation.

Evaluation research and development

We are looking for work that can show how research has contributed to public policy evaluation by creating specific tools, processes and protocols. The evaluation of policies relating to employment, sustainable development, public health, development aid, education and research, to name but a few is increasingly influenced by social science. It is therefore worth looking at the resulting innovations and the difficulties encountered. What are the most innovative and/or "convincing" evaluation methods? How have research tools and methods adapted, to directly or indirectly contribute to evaluation exercises?

We also welcome proposals dealing with how research can contribute to/enrich reflection on the relevance of public policy evaluation, its limits, its factors of success and its constraints. Papers might thus consider the framework and terms of reference, the tools (social enquiries, statistics, econometrics, impact indicators, monitoring systems, etc.) or the processes involved. Analyses of the quality or weakness of the findings obtained with certain evaluations are welcome as well. Given the reflexive purpose of the summer school, we are also expecting studies addressing the institutionalisation of evaluation and the development of meta-evaluations. What role do legislative frameworks, administrative cultures, research, evaluators' communities and scientific journals play in the development of public policy evaluation? Finally, we wish to bring in the analysis of the uses and usefulness of evaluations.

Academic disciplines and evaluation

The summer school intends to confront disciplines with one another, to analyse the links between scientific disciplines and evaluation. More and more academic disciplines have been showing an interest in evaluation since the pioneering work of political science in the United States in the 1950s. Analysing this history can shed new light on **the interactions between academic disciplines and evaluation.**

For instance, how far have sociology and political science come in their study of the history and institutionalisation of evaluation and the development of expert-knowledge? How do these academic disciplines understand the links between evaluation and new public management? How do they reposition evaluation within the context of growing surveillance power? How do they address the issue of evaluation cultures? Based on the work of management sociologists, it would be interesting to analyse the power and legitimacy issues crystallised by evaluation systems and to use these to analyse changes in contemporary public action. We are expecting papers discussing the links between quantification and evaluation, as well as work from the field of economics. This could relate to issues such as how evaluation has used counterfactual methods from the fields of epidemiology and experimental psychology. The interdisciplinary debate is a crucial space for exchange on the scope and limits of these approaches, and more generally on the role of econometrics in evaluation. Insights into the debates taking place between various schools in economics (institutionalists and mainstream) would also be enriching.

Contributions from the management sciences would be appreciated as well. Topics to explore include the links between evaluation and public management, information systems, survey methods (marketing research, data mining, consumer behaviour theories, etc.), or indicator-based management. The links with psychology, psychoanalysis and educational sciences also need to be explored to improve our understanding, for instance, of collective learning processes in the context of evaluation practice. Geography and the regional planning sciences also raise interesting issues for evaluation. The debates on the "relevant" scales for public action and its evaluation, and multi-scalar systems of adaptive management for evaluation relating to sustainable development are clear examples. Finally, issues pertaining to integrated evaluations and indicators, to the evaluation of territorial integration and to the integration of expert and lay knowledge in turn open up interdisciplinary debates which will need to be considered.

Ultimately the aim will be to adopt a cross-cutting approach to consider how the different scientific disciplines deal with and contribute to evaluation practice. How does evaluation raise new questions within disciplines with regard to concepts, theories and methods?

Epistemology and paradigms: links between research and evaluation

We welcome proposals addressing the conditions of the development of public policy evaluation research. What is the role played by specialised journals, the creation of research networks, the functioning of doctoral schools or research funding from public authorities? More broadly, we will seek to understand the limiting or developing factors of interdisciplinary approaches to evaluation. Are there central issues that can help organise research on evaluation? Does research on evaluation present particular problems when considered as an action science? Do systems of scientific knowledge production involve particular modes of exchange between researchers and practitioners?

Studying the links between research and evaluation also raises a number of epistemological questions. Above all, these concern evaluation itself. Which theory/ies should be used to understand the social and technical construction of evidence? Questions raised relate to the nature and ranking of evidence. This links back to the use of scientific knowledge for public action, as well as to the bridge between scientific and public judgements. Epistemological questions are also raised with regard to evaluation as a topic for research. For instance, debates need to be reviewed about method-based versus theory-based evaluation and the ensuing debates on theory-driven versus realistic evaluation in the broader context of the increasingly influential notion of evidence-based policy. The very existence of these debates begs to consider what peculiarities might structure the field of research on evaluation. Does evaluation entail a specific epistemological and methodological framework?

Finally, papers presented will **further our understanding of how the links between research and policy evaluation are structured.** Various terminologies are used: research "on", "about", "for" evaluation. These distinctions reflect the different stands taken in research on evaluation, a field whose borders remain fuzzy. These depend on the context (academic discipline, country, etc.) in which scientific work is carried out. Papers could take their reflection in several directions: science and its normative aim "for" public action — ethics of independence v. concerns over usefulness —; researchers' reflexive position in relation to the object of study — evaluation — or even their freedom of scientific production when they themselves are involved in evaluative practices; the bodies of theory they use — from the field of evaluation or from their own field.

Format of the papers and deadlines

Papers presented can either discuss ongoing or completed research, or present upcoming research (for example PhD projects). A paper proposal (200 words) will need to be submitted by **7 May 2010** (sfe.universite-ete@orange.fr). From there the scientific committee will operate a selection process (reply to authors: 30 May), and successful applicants will have to submit their completed papers by 15 July 2010.

Guidelines for authors and selection criteria

- The papers submitted must respect the following guidelines: they must be written in French or in English and must not be over 30,000 characters long (6000 to 8000 words) including bibliographic references.
- Page layout: Times New Roman, 12 points, single spacing; titles in bold and numbered 1; 1.1; etc.
- Two pages before the paper1: the first page must include the authors (specify the corresponding author + surname, first name, institution, function, academic discipline(s)), an abstract presenting the research subject(s), the research question and the results, as well as the methodology (500 words max.) and five key words. The second page is identical to the first, but must not contain the author references.

Papers will be assessed against the following criteria: correspondence to the themes put forward in the call for papers; quality of the research question and the approach; robustness of the empirical data used.1. These are not included in the 30,000 characters of the paper.

MORAL PANICS IN THE CONTEMPORARY WORLD

Brunel University/UK December 10-12, 2010

Contributions are invited for an international conference which will explore the continuing relevance of the notion of moral panic in analyzing a range of contemporary phenomena.

Almost four decades have passed since the initial development of the moral panic concept by Stanley Cohen, Jock Young and others. Since its emergence in the early 1970s from radical criminology, the moral panic concept has both been taken up by a variety of academic disciplines and entered wider popular and journalistic discourse, being applied in both cases to a wide range of empirical examples. Recent attempts to develop the moral panic concept have made connections to theories of risk, discourse and moral regulation. The concept has also been applied to the analysis of a growing range of examples, including issues related to health, lifestyle and the environment. It is clear that moral panic not only remains a topical concept, but also is one that has become increasingly widely used both within academia and the wider culture. However, perhaps precisely because the term is now so widespread, questions have been raised about the scope of its applicability and indeed about the adequacy of the moral panic concept itself.

This conference seeks to build on these recent criticisms, debates and developments, to explore and evaluate how the concept has developed and continues to do so, and how relevant it is to the analysis and understanding of current fears, risks, social problems and controversies. The central aim of the conference is to further the development of moral panic research via theoretical analyses, methodological discussions and empirical studies.

The central thematic strands of the conference are:

- Environment & Risk
- War & Terror
- Lifestyle & Health
- Crime & Deviance
- Immigration & Security
- Economic Crisis & Political Scandal

We invite papers which investigate these areas of current concern and which draw on the concept of moral panic, with empirical and theoretical rigour and originality.
