#### Conflict of Interest in Central and Eastern Europe

It appears in many spheres of social life, ranging from administration, politics, economy, culture to science and technology. Although diverse conflicts of interests are studied by social researchers from Central and Eastern Europe (CEE) who tend to agree about their ubiquity and importance in post-communist realities of CEE countries, they are usually studied in isolation as separate issues. Conflict of interest is usually studied from legal and administrative perspective, with a view on its legal regulation. Unfortunately, social researchers avoid using the term as an analytic tool. The aim of the conference it to fill the gap and ask about the role conflict of interests plays in different areas of social life in post-communist countries.
